Re: Philadelphia FIGHT Institutional Review Board Standard Fees

Philadelphia FIGHT utilizes its own local Institutional Review Board (IRB) for review of human subjects research. The Philadelphia FIGHT IRB (Federal IRB #00003010) is a group of individuals who serve on the board as volunteers. They convene at Philadelphia FIGHT, 1233 Locust Street, 5<sup>th</sup> Floor, Philadelphia, PA 19107.

The number and complexity of human research protocols at Philadelphia FIGHT have increased substantially in recent years. Each of these studies requires review and ongoing oversight by the IRB, a process that is vital to the FIGHT's ability to conduct research.

Philadelphia FIGHT charges IRB fees to Sponsors in order to maintain resources and continuing education for its local IRB. These fees are as follows:

Local IRB Initial Review .....	\$2,800.00
Local IRB Annual Renewal.....	\$2,250.00
Local IRB Amendment Review.....	\$1,700.00
Local IRB Administrative Amendment or ICF/ICF Addendum Review.....	\$600.00
Local Acknowledgement of Signed Authorization Agreement.....	\$600.00
